On May 20, 2021, the Government of El Salvador published the approved Law No. 738 for electric mobility. The main purpose of this law is the promotion of incentives to import and to use electric and hybrid vehicles in the public and private sector. Under this regulation, a 0% custom duty is established for electric and hybrid vehicles and ...

In parallel, Daniel ?lvarez, the Director-General of the Directorate General of Energy, Hydrocarbons, and Mines (DGEHM), asserted the Central Government's support for initiatives aimed at enhancing the quality of life for Salvadorans.
